#### **Executive Presbyter Report**

What an adventure it has been, since Robin and I began serving as Co-Executive Presbyters in April 2019: blessings, transformations, deep friendships, tremendous learnings, and God's all-sufficient grace were abundant; along with tornadoes, floods, and Covid, too. After a year of serving as your full-time Executive Presbyter over the past year, I've discerned that is now the right time for me to step away from this ministry.

During this stated Presbytery meeting, my final one as your EP, I want to recall a few of the significant accomplishments we have achieved together, during Robin's and my leadership, which go above and beyond the administrative and executive duties which also filled our ministry.

- We navigated helpful and grace-filled ways through the crises of the March 2020 tornadoes, Covid, the August 2021 Waverly floods, and the December 2023 tornadoes, with the generous support of many churches and individuals, along with grants and assistance from Presbyterian Disaster Assistance.
- Adapted to new staffing models and staffing changes: the unique Co-EP/ruling and teacher elder/married spouses model, the retirements of both Robin and Therese at the end of 2022, and the additions of Mary Catherine and Gregory at the end of 2022.
- Moved from the offices at Westminster Presbyterian Church, Nashville to virtual offices (our homes), now with the added meeting space at Second Presbyterian Church, Nashville.
- Added, inputted, and adapted to a new database to our administrative operations.
- Expanded communication through the bi-weekly Presbytery eNews and developed more meaningful connections through visiting every church in the Presbytery, plus NaCoMe, our four New Worshiping Communities, and our three UKirks.
- Developed financial policies which include definitions, purposes, and greater
  accessibility for all funds, improved financial efficiencies and transparencies
  through the assistance of our accountant/bookkeeper, Gina Andrews, presented
  the upcoming year's balanced budget for Presbytery approval at the fall stated
  meeting, based on committee inputs.
- Created the successful, urgently needed, and sustainable Nueva Vida Food Project, with Nourish Food Bank, through the hospitality of Glencliff Presbyterian Church, Nashville, and the ministry of Iglesia Presbiteriana Nueva Vida.
- Undergirded the challenges and changes in our four New Worshiping Communities – Iglesia Presbiteriana Nueva Vida, Telos @ Southminster, Rock Eternal Arabic Church, and Evangelical Presbyterian Arabic Church – with support, encouragement, and endorsements for PMA grants.
- Stepped in with support, direction, and planning with churches undergoing pastoral changes, particularly notable with Bellevue Presbyterian Church,

- Nashville, Downtown Presbyterian Church, Nashville and First Presbyterian Church, Columbia.
- Recommended the formation of administrative commissions to successfully and pastorally dissolve four churches: First United (Sparta), Mattie Smith Memorial (Silver Point), New Hope (Franklin), and Central (Culleoka).
- Intentionally modeled the value of investing time and energy into the cultivation of relationships of love and trust, particularly incorporated by the Commission on Ministry in their liaison relationships with congregations and pastors.
- Developed a revised Mission and Operations Manual which added the formation of a Social Justice Committee, an expansion of the membership and purposes for the Personnel Task Force, and an articulation of PMT's Guiding Principles.
- Added summer Neighborhood Pastors Lunches to our annual calendar.

These are all major movements forward yet they are still just the beginnings of what the Presbytery can do and be as a faithful people of God, serving Jesus Christ together with energy, intelligence, imagination, and love. There is a burgeoning spirit of collaboration, of innovation, of striving to be church in new ways. I hope the Presbytery has expanded its welcome at the tables (and Zoom rooms) where decisions are being made, inviting multiple voices to be respected and heard. I hope the challenges, changes, and crises we've all lived through have deepened our faith in God's astonishing wonders, invigorated our flexibility to new ways, and brought us to critically examine assumptions, patterns, and mindsets. New life beckons us forward, even as a PCUSA presbytery, in Middle Tennessee, in 2024.

My official retirement date is April 1, 2024. With unused vacation time, my final day of active service will be Thursday, March 21. Though the Presbytery does not have a policy for former elected staff persons, I intend to uphold the principles which inform the PMT Former Pastor Policy. Since I will be living within the bounds of the presbytery, as of April 1, I will remove myself from all interactions with committees, groups, and congregations of the presbytery. I will not attend Presbytery meetings, preach in any churches, nor attend any ordinations or installations. In any social settings or friendships which continue with members of the Presbytery, I will refrain from any conversations related to the current state of the Presbytery or its leadership. The one exception I request is to be present with Robin if she chooses to become regularly involved with one of the churches of the Presbytery. I will be available to the Stated Clerk, at her initiative, as well as anyone who follows me in this position. I covenant to maintain these boundaries for at least one year, and will also follow any guidelines determined by the Personnel Task Force, Administrative Committee, or the next Executive.

#### PERSONNEL TASK FORCE REPORT FOR 2/10 PRESBYTERY MEETING PACKET

The Personnel Task Force of the Presbytery of Middle Tennessee is not freestanding, but exists as a task force of the Administrative Committee. Since Ray Thomas announced his retirement in Fall, 2023, the Personnel Task Force has been consulting the Presbytery's Personnel Policies Manual and working closely with the Administrative Committee to chart a part into and through this transition in Executive Presbyter (EP) leadership.

The Administrative Committee has authorized the Personnel Task Force (PTF), along with an additional Administrative Committee member, to serve as the Bridge EP Search Team:

Heidi Hudnut-Beumler, TE, Westminster Nashville, Chair, PTF, and Administrative Committee member

Lavona Russell, RE, East Brentwood, Vice-chair, PTF member

Connie Hamblen, RE, Eastminster, Nashville, PTF member

Jack Baxter, RE, First, Columbia, PTF member

Jeff Kane, TE, Westminster, Columbia, PTF member

Mark Bryan, TE, Glen Leven, Nashville, Administrative Committee member

The Bridge EP Search Team was tasked with drafting a job description to recommend to the Administrative Committee for approval. That process is underway.

Broad outreach and networking is being undertaken by the Bridge EP Search Team. Potential candidates are being identified, and engagement with our Synod Executive Greg Goodwiller and Executive Presbyters and Transitional Executive Presbyters is unfolding. Any interested candidates or suggestions for candidates should be in touch with Heidi Hudnut-Beumler as chair, or any member of the Bridge EP Search Team.

The Bridge EP Search Team will conduct interviews and present the top candidate(s) to the Administrative Committee for interviewing. Working with the Finance Committee, the Bridge EP Search will recommend a package to the Administrative Committee, as part of the Administrative Committee's final approval. The Presbytery will be kept informed.

This Bridge EP position is short term, estimated to be up to six months, renewable. Soon, a similar process will begin to seek a Transitional EP. This position is intended to be longer, and this period of time will include work with a consultant, as directed by the Administrative Committee, to help us as a Presbytery take a deep dive into who we are, who and what God is calling us to be, and how to get there.

When the Presbytery is ready to set up a Search Committee for the installed EP position, the Presbytery Nominating Committee will present a slate to the Presbytery for approval, and a position description recommended by the Personnel Task Force to the Administrative Committee for authorization will require approval by the Presbytery prior to starting a search, as per the Personnel Policies Manual.

The Bridge EP Search Team/Personnel Task Force is working actively to support our three Presbytery staff members during this time of transition. Ray's last day in the office is March 21, when he will take one week of accrued vacation time. His official retirement date is March 31.

We are excited to celebrate Ray's retirement and give thanks for his ministry and leadership in the Presbytery of Middle Tennessee at the February 10<sup>th</sup> Presbytery meeting! As we give thanks for him, we also give thanks for Robin's serving as Co-EP with him for four of his five years. May they be blessed with a fulfilling and fruitful retirement, and know of our gratitude for their leadership and ministry among us!

# ADMINISTRATIVE COMMITTEE REPORT TO THE PRESBYTERY OF MIDDLE TENNESSEE FEBRUARY 10, 2024

#### **INFORMATION**

- The Administrative Committee ordinarily meets on the second Wednesday of each month, hybrid format in person and via Zoom, at 4:00 pm following the meeting of the Finance Committee.
- The Administrative Committee receives regular reports from the Executive Presbyter, the Stated Clerk, and the Treasurer.
- The Administrative Committee welcomed Sandra Randleman, TE, First Nashville, and Chris Williams, RE, FPC Pulaski and thanked Stephen Yates, TE, FPC Tullahoma, and Doug Berry, RE, Westminster Nashville, for their exemplary service during their terms on the committee.

#### **ADMIT TO RECORD**

- 1. The committee reviewed the November 9 Stated Presbytery meeting at FPC Clarksville which the quorum was lost following lunch. \$1678 was collected via the offering for the Sudenese Church.
- 2. The Administrative Committee called and approved plans for the November 30 called Presbytery meeting, with the following items to be considered: all items which were offered for admit to record and all actions items will be put to ratification vote; Anne Catherine Oeser will be nominated as the YAAD for the 226<sup>th</sup> GA.
- 3. The Administrative Committee called and approved plans for a called presbytery meeting on January 11, 2024 to approve the sale of the New Hope PC property for \$405,000.
- 4. The Administrative Committee approved the agenda for the stated meeting of February 10, 2024: will be held by Zoom, moderator and co-moderator will be installed, the Rev. Stephen Yates will preach, and the offering will go to tornado relief distributed through FPC Clarksville and FPC Springfield.
- 5. The Administrative Committee approved the following members of the Policy Compliance Task Force: Chris Williams, chair, Doug Berry, and Erin Howton-Angel.
- 6. The Administrative Committee approved the adaptation of the Safe Church template approved in 2021 to presbytery for review by the Policy Compliance Task Force.
- 7. The Administrative Committee approved the creation of a Bridge EP Search Team, chaired by Heidi Hudnut-Beumler. Other members include Mark Bryan as well as the Personnel Task Force members.
- 8. The Administrative Committee approved the exploration of engaging Healthy Churches as it moves forward in the search for the next Executive Presbyter as well as engaging insight and advice from our synod staff.
- 9. The Administrative Committee approved the following dates for the stated meetings of 2025:
  - February 8, via Zoom
  - May 3, in person, location TBD
  - August 7, via Zoom
  - November 6, in person, location TBD
- 10. The Administrative Committee concurred with the Finance Committee in the creation of a task force to support Southminster and a task force to discuss the proposed long term lease of Trinity by the Lindon Waldorf School.

- 11. The Administrative Committee, in concurrence with the Personnel Task Force, accepted with regret the new retirement date of March 31, 2024 by Ray Thomas.
- 12. The Administrative Committee heard a report from the Ad Hoc Committee. The 2024 nominating Task Force is composed of: Chair, Leonard Jordan, CRE, St. Andrews; Scott Huie, TE, FPC Bellevue; Stephanie Coleman, RE, DPC; Shirley Puckett, RE, Buffalo Valley; Vicky Harwell, RE, FPC Pulaski; Stephen Yates, TE, FPC Tullahoma.
- 13. The Administration Committee heard a report from the EP on the disaster relief funds from the Presbyterian Disaster Agency.
- 14. The Administrative Committee approved the Stated Clerk's request to consider bringing forth a motion to change the quorum at stated meetings.
- 15. The Administrative Committee approved the boundary description of the presbytery as written by the Office of the General Assembly.
- 16. The Administrative Committee approved the Stated Clerk's request to consider amending the language of the Mission and Operations Manual to reflect the language of the Book of Order 2023-2025 on retired ministers.

#### RECOMMENDATION

1. The Administrative Committee, upon the request of Decherd FPC, recommends that an Administrative Commission be formed to dissolve the congregation. The charge, to be included in the permanent record, is included in the packet of materials, and the commission is comprised of the following individuals: Steve Elkins, RE, FPC Murfreesboro; Ellen Hill, TE, Honorably Retired, Tom Bagley, TE, FPC Normandy, Charlotte Broyles, RE, FPC Tullahoma.

#### **Decherd Presbyterian Church, Decherd – Administrative Commission**

The Administrative Committee, at the request of the Decherd Presbyterian Church, Decherd, TN, recommends that the Presbytery of Middle Tennessee create an administrative commission for the dissolution of its congregation.

- A. The Administrative Committee recommends that the administrative commission be charged as follows:
  - (1) Assume original jurisdiction, with the full powers of the session.
  - (2) The administrative commission shall:
    - a. assist members to wind up the affairs of the church, and transfer its remaining members. The Stated Clerk shall be authorized to grant letters of dismissal to members whose names are still on the roll for up to one year after the closing worship service; and
    - b. plan, in consultation with the members of Decherd Presbyterian Church, Decherd, if so desired, a closing worship service, to honor the life, ministry, and witness of the church.
- (3) The administrative commission shall receive the records of the session, including, but not limited to, all session minutes, the church's roll / register, all minutes of congregational meetings, all minutes of the Board of Deacons, and any other legal and financial records. These records will be deposited with the Stated Clerk of presbytery, who shall transmit them to the Presbyterian Historical Society.
- (4) Under Form of Government, Chapter IV, G-4.02, all property of Decherd Presbyterian Church, Decherd, Tennessee, is held in trust for the Presbyterian Church (U.S.A.). The administrative commission appointed by the Presbytery of Middle Tennessee, on February 10, 2024, is authorized to take possession of all real and personal property, financial records, inventories of equipment, and any other assets, and arrange for transfer of title to the Presbytery of all accounts and real property known to be in possession of Decherd Presbyterian Church, Decherd.
- (5) The administrative commission shall consult with the session of Decherd Presbyterian Church, Decherd, regarding requests the congregation may have related to the disposition of equipment and memorials and other property of the church.
- B. The Trustees of presbytery shall have claim, on behalf of the Presbytery of Middle Tennessee, to any property of Decherd Presbyterian Church, Decherd not known at this time or property which may come to Decherd Presbyterian Church, Decherd as the beneficiary of a will or trust not known at this time.
- The commission shall confer with the Trustees of the Presbytery of Middle Tennessee regarding the disposal of the property of Decherd Presbyterian Church, Decherd. The Trustees of presbytery shall be responsible for the property, until such time as presbytery approves the disposition of the property. The administrative commission shall make a recommendation to the Presbytery of Middle Tennessee, in consultation with the Trustees of presbytery, for the sale of the property of Decherd Presbyterian Church, Decherd.
- D. The commission will report to the Administrative Committee at least every three months.

- 1. We welcome our newest members to the committee, Rev. Donovan Drake to fill the term of the Rev. Toby Mueller (Class of 2025) who resigned in 2023, and Chris Williams who joins the committee by virtue of his office of Moderator-in-Nomination.
- 2. Financial statements are attached including year to date activity through December 2023 and monthly activity for December 2023. A summary of both the balance sheet and the income statement is also attached. Items to note:
  - a. 2023 pledges from our member churches exceeded budget by \$21,000. Thank you!
  - b. 2023 total expenses came within \$500 of the 2023 budgeted expenses
  - c. The majority of our investments, almost \$2 million invested in 60% equity and 40% cash, are invested in several Vanguard funds and are carefully monitored by Anders Hall. Our Vanguard balance gained \$244,000 in investment income over the course of 2023. Investment income was especially high for December, at \$81,000.
- 3. In response to a draft letter of intent received from Rev. Sally Hughes for a potential long-term lease between Trinity Presbyterian and the Linden

- Waldorf School, a letter was sent back to both parties and their lawyers from the Finance and Administration committees regarding concerns of the potential long-term lease. A task force was assigned to work with Trinity regarding these concerns of Steve Douse (RE Nashville, First), Allen Kennedy (RE Nashville, First), and Jane Herring (TE Chair of Admin.).
- 4. The property of the former New Hope Presbyterian Church in Franklin, Tennessee was sold to LifeStream Church for \$405,000. This sale was approved at the called presbytery meeting on 1/11/24. The property sale was closed on 1/24/24 with proceeds of \$380,988 to the presbytery.
- 5. The Finance Committee convened a listening team to support Southminster Church at its request. The original members of the team were Ray Thomas, Donovan Drake, and Evelyn Graham. The Finance Committee has determined that COM is better positioned to serve this congregation and has referred the team to COM. The Rev. Graham resigned from the team.

#### RECOMMENDATION

1. Finance approved the charge for an Administrative Commission (AC) for Brick Church Presbyterian in Cornersville, TN to determine the church's extinction status. If the church is considered extinct, the AC in collaboration with the Trustees would be authorized to close the church and sell the church property. Currently, the church building is considered hazardous. Proposed members of the AC are: Amy Stoker, Carol Foster, Chris Williams, and Jim Moran. The charge to the AC is attached to the finance documents. The Finance Committee recommends the formation of this AC.

#### Brick Church Presbyterian, Giles County, Tennessee – Administrative Commission

The Finance Committee recommends that the Presbytery of Middle Tennessee create an administrative commission for the purpose of determining whether the Brick Church Presbyterian Church has become extinct by reason of the dispersal its members, the abandonment of its work or other cause. <sup>i</sup>

The Finance Committee recommends that the administrative commission be charged as follows:

- (1) The administrative commission shall attempt to contact known members or individuals with knowledge of the church.
- (2) If successful, the commission shall determine with those members whether the session of the church is able to exercise its authority. If so, the commission shall walk alongside the session to determine whether the congregation shall be dissolved. If the commission determines that the session is unable or unwilling to manage wisely its affairs, the administrative commission shall assume original jurisdiction, with the full powers of the session.<sup>ii</sup> The commission shall then determine whether the congregation shall be dissolved.
- (3) The administrative commission shall assist members to wind up the affairs of the church and transfer its remaining members. The Stated Clerk shall be authorized to grant letters of dismissal to members whose names are still on the roll for up to one year after the closing worship service.
- (4) If the commission is unable to contact members, it shall declare the congregation to be extinct pursuant to G-4.0205 as cited in the prologue.
- (5) Under Form of Government, Chapter IV, G-4.02, as noted above, all property of Brick Church Presbyterian, Brick Church, Giles County, Tennessee, is held in trust for the Presbyterian Church (U.S.A.). The administrative commission appointed by the Presbytery of Middle Tennessee on February 10, 2024, is authorized to take possession of all real and personal property, financial records, inventories of equipment, and any other assets, and arrange for transfer of title to the Presbytery of all accounts and real property known to be in possession of Brick Church Presbyterian Church, Brick Church, Giles County.
- (6) The administrative commission shall receive the records of the session, including, but not limited to, all session minutes, the church's roll / register, all minutes of congregational meetings, all minutes of the Board of Deacons, and any other legal and financial records. These records will be deposited with the Stated Clerk of presbytery, who shall transmit them to the Presbyterian Historical Society.
- (7) If possible, the administrative commission shall consult with the session or remaining members of Brick Church Presbyterian Church, Brick Church, Giles

County, regarding requests the congregation may have related to the disposition of equipment and memorials and other property of the church.

- (8) The Trustees of presbytery shall have claim, on behalf of the Presbytery of Middle Tennessee, to any property of Brick Church Presbyterian not known at this time or property which may come to Brick Church Presbyterian as the beneficiary of a will or trust not known at this time.
- (9) The commission shall confer with the Trustees of the Presbytery of Middle Tennessee regarding the disposal of the property of Brick Church Presbyterian. The Trustees of presbytery shall be responsible for the property, until such time as presbytery approves the disposition of the property. The administrative commission shall make a recommendation to the Presbytery of Middle Tennessee, in consultation with the Trustees of presbytery, for the sale of the property of Brick Church Presbyterian.
- (10) The commission will report to the Finance Committee at least every three months.

" G-4.0205 Property of a Dissolved or Extinct Congregation

Whenever a congregation is formally dissolved by the presbytery, or has become extinct by reason of the dispersal of its members, the abandonment of its work, or other cause, such property as it may have shall be held, used, and applied for such uses, purposes, and trusts as the presbytery may direct, limit, and appoint, or such property may be sold or disposed of as the presbytery may direct, in conformity with the Constitution of the Presbyterian Church (U.S.A.).

Presbytery, being composed of the ministers of the Word and Sacrament and commissioners elected by the session of congregations within its district, has a particular responsibility to coordinate, guide, encourage, support, and resource the work of its congregations for the most effective witness to the broader community. In order to accomplish this responsibility, the presbytery has authority to:

e. assume original jurisdiction in any situation in which it determines that a session cannot exercise its authority. After a thorough investigation, and after full opportunity to be heard has been accorded to the session, the presbytery may conclude

that the session of a congregation is unable or unwilling to manage wisely its affairs, and may appoint an administrative commission with the full power of session. This commission shall assume original jurisdiction of the existing session, if any, which shall cease to act until such time as the presbytery shall otherwise direct.

Report from the Committee on Preparation for Ministry to the Presbytery of Middle Tennessee

The Committee on Preparation for Ministry (CPM) is responsible for guiding, caring for, and examining candidates for ministry in our denominational process. All those seeking to become teaching elders/Ministers of the Word and Sacrament must move through the steps detailed in the CPM checklist that can be found on the presbytery website. And there are a lot of steps!

Typically, the full presbytery is only involved when prospective teaching elders desire to move from the inquiry phase to the candidacy phase and are "examined with respect to personal Christian faith, forms of Christian service undertaken, and motives for seeking the ministry." The presbytery then votes to "affirm or deny the examination." Enrollment as an inquirer and being certified "ready to receive" a call are handled by the CPM and those actions are reported back to the presbytery. Occasionally the CPM will consider requests to validate a ministry to which a ready-to-receive candidate may be ordained.

These are usually settings that are not in a church but which may be considered pastoral (e.g. hospital, hospice, prison or street chaplaincy; certain positions in seminaries and divinity schools; or work at the denominational level).

#### **RECOMMENDATION**

1. The Committee on Preparation for Ministry recommends that Inquirer Mallory Hammond be examined for Candidacy.

## A. A statement of your understanding of Christian vocation in the reformed tradition and how it relates to your sense of call;

My understanding of Christian vocation in the reformed tradition begins with God in action. God by his breathed-out word is the creator, maker, and sustainer of life and faith and, therefore the author of any calling. In this created order, the Triune God desires to be in a relationship with his creation, humanity. God demonstrates this covenant relationship with his people throughout the whole of the scriptures. Because of the death, resurrection, and ascension of Jesus and the indwelling of the Holy Spirit, this relationship is on offer even to sinful humankind. I acknowledge my need for this radical saving love from God and am thankful for the gift of Jesus Christ and the great guide and help of the Spirit as I move throughout the world and seek to follow Christ in his mission to love people, places, and things to life.

One of the ways I respond to this radical saving love and invitation into God's family is to use the work of my hands, the gifts I have, and the time I've been given to serve God in all I do. One could do this in a number of ways but after years and layers of revelation of my call to vocational ordained ministry, I am humbled and overjoyed to be able to respond to the call to vocational ordained ministry. I have loved the local church since I was a little girl and nothing lights my heart up more than to receive a call to serve and minister to a local congregation as an associate pastor. In this role, I would be called to gently tend to the needs of the gathered people of God through prayer, teaching, encouragement, preaching, playing, laughing, crying, and sharing the sacraments.

## B. A statement of personal faith which incorporates an understanding of the reformed tradition;

I affirm and hold to the Apostle's Creed (along with the Nicene and others shared in the Reformed tradition) which beautifully states the faith; naming God as Father, maker of heaven and Earth, Jesus as God's son, and my Lord. I also believe in the Holy Spirit who is the third member of the trinity and guides, teaches, corrects, and encourages God's people how to live in the world to bring God glory and flourishing to God's creation. I affirm that Scripture is God's breathed-out word and reveals to humankind the character of God and his ongoing rescuing and restoration story for humanity through the life, death, and resurrection of Jesus. Through the power of the Holy Spirit, I am aware of my deep need for rescue and restoration and I am forever grateful to be

brought into God's forever family. Proceeding from that great love from God, I know that I am then called to walk out the faith in the world by loving my neighbors, acting in justice and mercy, and sharing the great gift of God's love with those around me.

## C. An analysis of at least one concept from the personal faith statement regarding what it suggests about God, humanity, and their interrelationships;

I have been spending time with two images of the relationship between God and humanity. The first is God as Father and we, as God's people, are his children. The other is from Psalm 23, thinking about the Lord being the shepherd and we, as God's people, are the sheep. Both images show that God is above humanity. God is the creator of all things and his ordered design, rule, and desires supersede ours because of his power, might, perfection, justice, goodness, and omniscience. So while there would be natural order, rule, authority, discipline, and consequences in both the shepherd/sheep image and the father/child image, there is also such a tenderness and closeness in the relationship. The shepherd provides food, water, protection, and rest for the sheep. The father knows the child and the child recognizes the father's voice and finds comfort\* in that familiar voice.

\*I know that the Father metaphor is not a comfort to all who have broken or harmful relationships with father figures. I find quite a bit of comfort in the imagery in my personal life and experience but this is not a universal comfort and this imagery, while used in scripture, should be used gently in a congregational setting.

## D. A statement of what it means to be Presbyterian, indicating how that awareness grows out of participation in the life of a particular church;

The Foundations of Presbyterian Polity says that the Constitution of the Presbyterian Church (USA) is made up of the Book of Confessions and the Book of Order. The Foundations of Presbyterian Polity highlights its methodology of government by defining the layers of authority: one church, governed by presbyters, gathered in councils, to seek and represent the Will of Christ, decisions are made by majority vote, review and control, ordination by council, shared power, exercised jointly, with general authority of councils.

"F-3.0208 Shared Power, Exercised Jointly

Ecclesiastical jurisdiction is a shared power, to be exercised jointly by presbyters gathered in councils."<sup>1</sup>

The Foundations of Presbyterian Polity also states that Christ is the Foundation of the Church. This defines why the gathered local church and the Church exist. We are to bear witness to the good news of Christ who is our firm foundation.

#### "F-1.0205 Christ Is the Foundation of the Church

In Christ all the fullness of God was pleased to dwell, and through Christ God reconciles all things, whether on earth or in heaven, making peace by the blood of the cross (Col. 1:19–20). In Christ's name, therefore, the Church is sent out to bear witness to the good news of reconciliation with God, with others, and with all creation. In Christ the Church receives its truth and appeal, its holiness and its unity "<sup>2</sup>

# E. A statement of self-understanding which reflects your personal and cultural background and includes a concern for maintaining spiritual, physical, and mental health;

I cannot remember a day I have not known the Lord. This is not to my credit as I know, I could only love him because he first loved me (1 John 4:19). I came to know the Lord at an incredibly young age. I loved the church in my earliest years because I loved Bible stories. A love of stories would be a theme of my childhood and adolescence and I adored learning about Jesus. But those stories became real to my heart when my great-grandfather died when I was four years old. He was my dearest friend and I struggled to process his death when I was small. My parents used this as an opportunity to connect what I loved learning about at church with what was true for my grandpa. He loved Jesus and trusted him as his savior so he gets to live with Jesus forever. This made all of the stories I loved come crashing into reality and it clicked, as much as it could for a little girl. I wanted to give all I knew of myself to all I knew of Jesus. I have loved the church my entire life. Other than God's great kindness to me in this gift, I can otherwise credit my parents, Dave and Gigi for tending to the fire of love for God's church in my heart.

I know I have grown up with a lot of privilege as a white, middle-class, college-educated, woman with incredibly encouraging parents. I did grow up in a hyper-conservative, theologically fundamentalist environment, so I have to still do some work against thinking that as a woman I need to be "good", "amendable, and passive" to all conflict and authority, and positive all of the time to please God and those around me. Through the work of the Holy Spirit, dear friendships, mentorship, and an ongoing relationship with a therapist, I can work on trusting the secure relationships with God, myself, and

my community to be a kind and strong truthteller, who is a peacemaker, not just a peacekeeper.

F. a statement of your understanding of the task teaching elders perform, including an awareness of your specific gifts for ministry and of areas in which growth is needed.

According to the Book of Church Order section *G-2.05*, "MINISTERS OF THE WORD AND SACRAMENT: THE MINISTRY OF TEACHING AND PASTORAL CARE" says, "Ministers of the Word and Sacrament (also called teaching elders and pastors) shall in all things be committed to teaching the faith in word and deed and equipping the saints for the work of ministry (Eph. 4:12). They may serve in a variety of ministries, as authorized by the presbytery. When they serve as preachers and teachers of the Word, they shall preach and teach the faith of the church, so that the people are shaped by the pattern of the gospel and strengthened for witness and service. When they serve at the font and table, they shall interpret and "show forth" the mysteries of grace in word and action, lifting the people's vision toward the hope of God's new creation. When they serve as pastors, they shall support the people in the disciplines of the faith amid the struggles of daily life. When they serve as presbyters, they shall participate in the responsibilities of governance, seeking always to discern the mind of Christ and to build up Christ's body through devotion, debate, and decision"<sup>37</sup>

I believe the work of teaching elders is to preach and teach the gospel found in the Holy Scripture, lead the congregation in gathered worship, give the sacraments, and walk with the hurts, triumphs, needs, and celebrations of a congregation. They are to model and lead how the love of God then moves us to loving our neighbor and doing acts of justice and mercy near and far in the world. Teaching elders are also meant to participate in their work as presbyters as well, as a means of loving and protecting the purity and the peace of the Church.

# COMMITTEE ON CHURCH TRANSFORMATION February 2024 Report to Presbytery

The purpose of the Committee on Church Transformation (CCT) as stated in the presbytery's plan is: "to engage renewed enthusiasm for church growth. God is calling us to new ways of being church, and this may include: annual "Celebrate the Journey" reports; creation of a Church Transformation and Growth strategy; Healthy Congregation seminars; planting new churches and redevelopment of churches; and prayer covenant and prayer summits."

# Admit to Record:

We admit to record the following four items related to our team's purpose and which are elaborated upon in this report:

- 1. "The creation of a Church Transformation and Growth strategy..." An invitation to churches and pastors to join a Presbytery of Middle Tennessee "Cohort of Innovation."
- 2. "Healthy Congregation seminars..." We have invited Operation Andrew to present to the Presbytery of Middle Tennessee churches (April) their <u>State of Nashville</u> report conducted by Barna Research.
- 3. Our "Celebrate the journey" story highlights the new worshiping community at Nueva Vida.
- 4. "To engage renewed enthusiasm for church growth... God is calling us to new ways of being church..." We request from the Administration Committee and the Personnel Committee that "Church Transformation and Growth strategy" is identified as a hiring priority for the transition executive presbyter and for the eventual executive presbyter and furthermore that this priority is reflected in the recruiting, interviewing, and hiring of these candidates. Additionally, we request that the Administration Committee outlines the process to the body of the Presbytery no later than the February 10th presbytery meeting.

#### Further elaboration on the Admit to Record items:

1. "The creation of a Church Transformation and Growth strategy...: The Committee on Church Transformation is forming a cohort specific to the Presbytery of Middle Tennessee focused on church innovation and the cohort will start in February. We have partnered with Cyclical, Inc who is facilitating the cohort of up to 15 individuals intended for pastors and moderating the online community and the bevy of helpful resources and tools. <a href="https://cyclicalinc.com/">https://cyclicalinc.com/</a>. See <a href="Cyclical Culture Membership">Cyclical Culture Membership</a> Community. We are funding 1 full individual/church membership (\$65.00 per month)

through our Restricted Account 3001-04. At time of this report we have 6 spots available; if interested, please contact Keith Gunter or John Hilley.

- 2. "Healthy Congregation seminars...": We have invited Operation Andrew to present to the Presbytery of Middle Tennessee churches their <u>State of Nashville</u> report conducted by Barna Research. This 2 hour session (April's date, time, and location will be announced by February 10) and its intended to help churches <u>across our presbytery</u> better understand the reality of their neighbors.
- 3. "Celebrate the Journey" Highlight: Our presbytery's LatinX emphasis taking place at Nueva Vida (ESL and the worshiping community): At The Nueva Vida Presbyterian Church, we have been celebrating a bilingual fresh worshiping experience the first Sunday of every month called "Brunch with Jesus". The average attendance is between 40 50 people. We have activities for children, youth, and adults.



Also, we offer English as a Second Language class once a week to more than 40 students with the support of 6 tutors. We offer a hot meal for students and their families thanks to the kind contribution of The Nashville Food Project. The first 45 minutes students can register, eat dinner, practice English, and to build community. Sometimes, community organizations share information about available resources during that time. Then students have a small group class for 1 hour and a half. ESL classes are oriented to teach them the basics for their daily communication.

Additionally, we feed families through the Nueva Vida Food Project, which is part of the Matthew 25 movement of the PCUSA, is a collaborative ministry of Glencliff Presbyterian Church, Iglesia Presbiteriana Nueva Vida, the Presbytery of Middle Tennessee, and Nourish Food Bank in Murfreesboro.

# STATED CLERK REPORT TO THE PRESBYTERY OF MIDDLE TENNESSEE FEBRUARY 10, 2024

#### **INFORMATION**

- 1. Annual Statistical Reports were emailed to clerks of session in January. If you did not receive a report form and instructions, please contact the stated clerk. The deadline for churches to enter their own information is Thursday, February 15 at 10:59 pm CST.
- 2. A workshop for Middle Tennessee Presbytery clerks of session was held December 5<sup>th</sup> with Kris Valerius of the OGA. The Zoom event was recorded and is available on the Stated Clerk's page on the PMT website.
- 3. Session minutes will be reviewed in the coming months. Information will be emailed to clerks of sessions.
- 4. Supplemental reports are in the meeting packet; please read them, as they contain important information about the work of the presbytery committees, commissions, and taskforces.
- 5. The Stated Clerk of the Synod of Living Waters, the Rev. Charlie Evans, has resigned effective January 31, 2024. We are grateful for his service and leadership.
- 6. The Stated Clerk, with the Operations Coordinator and the Executive Presbyter, held a Committee Orientation via Zoom on January 6<sup>th</sup>, 2024. The event was well attended and all committees have begun their work.
- 7. The Stated Clerk provided training for newly elected ruling elders at FPC Gallatin at the invitation of the session.

#### ADMIT TO RECORD

- 1. The Stated Clerk has received the minutes of the Commission to Install the Rev. Zach Sasser as pastor of Downtown Presbyterian Church, Nashville. The members of the commission were: The Rev. Ray Thomas, Elinor Foster, RE, the Rev. Barry Chance, Eastminster Presbytery, Debra Gentry, RE, the Rev. Warner Durnell, the Rev. Adrian White, and the Rev. Keith Gunter, and Jack Henderson, RE, Debra VanDerveer, RE, and Dixie Williamson, RE. [minutes to be included in permanent record]
- 2. The 2022 minutes of the Presbytery of Middle Tennessee were approved without exception by the Synod of Living Waters at its stated meeting on January 22, 2024.
- 3. The Stated Clerk was informed of the death of Honorably Retired TE the Rev. Harry Clewer on October 24, 2023.
- 4. Three remedial complaints were filed against the presbytery by an individual member. The complainant withdrew all complaints and the Synod PJC filed an order of dismissal on January 23, 2024. The Committee of Counsel is dismissed with thanks for their dedicated and time consuming service in the middle of the busy holiday seasons of Thanksgiving, Advent, and Christmas.
  - 5. The Stated Clerk asks to admit to record two items from the supplemental

report of the Committee on Mutual Support, and the Report from the commissioner to the Stated Meeting of the Synod of Living Waters.

#### Recommendations

- 1. Because the phrase "Honorably Retired" is no longer used in the Book of Order, the Manual of Mission and Operations must be amended to be in compliance. The Stated Clerk, with the endorsement of the Administrative Committee, recommends a motion to amend the Manual on page 5 to read "The rolls of teaching elders who are members-at-large or Honorably Retired or Retired and live out of state, or are not able to participate in the work of the Presbytery, will be adjusted for the purpose of parity." The language in red font should be added. This motion requires a two-thirds majority vote to be passed.
- 2. The Stated Clerk, with the endorsement of the Administrative Committee, recommends a motion to amend the Manual of Mission and Operation by deleting the word "Honorable" on page 15 because the phrase "Honorably Retired" is no longer used in the Book of Order. This motion requires a two-thirds majority vote to be passed.
- 3. The Stated Clerk recommends with the endorsement of the Administrative Committee that the required quorum for a stated meeting be reduced from 75 commissioners to the following: 15 Teaching Elders, 15 Ruling Elders, and at least eight congregations represented among the 30 individuals. The Book of Order, G-3.0304, states: "A presbytery may set its own quorum, but it shall be not fewer than three ministers of the Word and Sacrament who are members of the presbytery and three ruling elder commissioners from three different congregations." This motion requires a two-thirds majority vote to pass.
- 4. The Stated Clerk recommends with the endorsement of the Administrative Committee that the Manual of Mission and Operations be amended on page 2 by adding the following boundary description on line 43: The geographic district of the Presbytery of Middle Tennessee consists of the counties of Bedford, Bledsoe, Cannon, Cheatham, Clay, Coffee, Cumberland, Davidson, Dekalb, Dickson, Fentress, Franklin, Giles, Grundy, Hardin, Hickman, Houston, Humphreys, Jackson, Lawrence, Lewis, Lincoln, Macon, Marion, Marshall, Maury, Montgomery, Moore, Overton, Perry, Pickett, Putnam, Robertson, Rutherford, Sequatchie, Smith, Stewart, Sumner, Trousdale, Van Buren, Wayne, Warren, White, Williamson, and Wilson, all in the state of Tennessee; with the exception that the Fairfield Glade Community Church in Cumberland County is a member of the Presbytery of East Tennessee and the First Presbyterian Church of Savannah in Hardin County is a member of the Presbytery of the Mid-South. This motion requires a two-thirds majority to pass.

#### SYNOD REPORT

The Synod of Living Waters met via zoom for its annual meeting on Monday, January 22<sup>nd</sup>. Opening worship included a sermon by the new president of Louisville Seminary, Andrew Pomerville, who preached on the call of Abraham in Genesis 12 and the ethical exhortations of I Corinthians 7. Taking his theme in part from the weather he compared the responses to blizzards, winter, and ice age with a call for Synod and the church to see ourselves in a new age, instead of trying to recreate how things have been done, but to be open to where God calls us to now in our new environment. Also leading worship were the Rev'd Ann Laird Jones, moderator from St. Andrew Presbytery, and musician Creighton Holder who rendered a beautiful arrangement of the hymn tune PROSPECT. Closing hymn was "How Clear Is Our Vocation, Lord."

Among the highlights of the reports was, of course, the continued exciting news from the Living Waters Clean Water project, now thirty years old. With its theme "All God's Children deserve clean water" we were reminded that 600 million children still do not have access to clean water. There are now over 1,100 clean water partnerships worldwide in 28 countries in the name of our church. 2,600 church volunteers have been trained at Clean Water U, now twenty years old. They now have produced VBS curriculum for all ages which will be presented at the upcoming APCE convention. The most important new program is LEGACY FUNDING for Living Waters, adopted by the Synod, and providing a means for our churches to leave gifts to the Living Waters endowment, the WORLD LEGACY FUND for continued legacy gifts to this important mission. Churches that are no longer to continue have opportunity to leave a legacy in their name to Living Waters.

Among the new relationships established by Synod in addition to colleges and seminaries is the Presbyterian Home for Children, located in Talledega, Alabama for homeless children and mothers and for blind and deaf children. Cindy Fisher, flautist, is a representative for this important institution. Relations continue with Louisville and Columbia Seminary, the Board of Pensions (which is undergoing changes to make pension support available for smaller churches), Maryville College, Tusculum University (to be featured on an episode of The College Tour on Amazon Prime), King University, Rhodes, and University of Pikeville (buildings wonderful medical programs and buildings), all Presbyterian institutions within our bounds.

There is also a revival of the Virtual VOICE which will communicate Synod ministries four times a year. It will also have daily devotionals. Finally, more than

half of Synod's budget (which Presbytery supports through per capita giving) goes to mission. Synod of Living Waters encompasses the twelve presbyteries in the mid-south area, although it was announced that our church in Phenix City is being moved to the Synod of South Atlantic because of geography. This is my second round as a Synod commissioner in Living Waters and it is always a homecoming for me, having been a candidate from St. Andrew Presbytery as well as a member there as well as my present 30 year membership in Middle Tennessee Presbytery. I'm grateful for the opportunity and am enthusiastic about Synod's work.

# PRESBYTERY OF MIDDLE TENNESSEE MINUTES OF ONE HUNDRED FIFTY FOURTH STATED MEETING NOVEMBER 9, 2023

The 154th Stated Meeting of the Presbytery of Middle Tennessee met in person at First Presbyterian Church, Clarksville, on Thursday, November 9, 2023. Stated Clerk Mary Catherine Sevier provided an orientation for first time commissioners. Moderator Stephen Yates addressed the gathering at 10 am and announced that a quorum was not present. At Moderator Yates's suggestion, the gathering moved into worship following a welcome from the host church.

#### **WELCOME**

The Rev. Greg Glover, Pastor at First, Clarksville offered words of welcome.

#### WORSHIP

Worship was led by the Rev. Greg Glover with Rev. Ray Thomas assisting. David Paduill, RE at the Sudanese Church in Gallatin, preached. Communion was received, and the Sudanese Church Choir provided music. The offering went to the Sudanese Church.

Following worship, The Moderator announced that a quorum had been achieved as presbyters continued to arrive during worship. He convened the meeting at 11:35 am with an opening prayer.

# ADOPTION OF AGENDA/DECLARATION OF QUORUM / STATEMENT OF PROCEDURES / FIRST TIME COMMISSIONERS / CORRESPONDING MEMBERS

Moderator Yates declared a quorum was present. The Presbytery's Mission and Operations Manual and the Book of Order provide for the seating of corresponding members and teaching and ruling elders with voice and those with voice and vote. Any ruling elder serving as presbytery's Moderator, Vice-Moderator, Moderator-in-Nomination, chairs of committees, members of the Administrative Committee, members of the Finance Committee, and the Moderator of Presbyterian Women, are enrolled as members of presbytery and shall have voice and vote. Ruling elders commissioned to particular pastoral service and ruling elders who have previously served as presbytery moderator, within five years of completion of his/her term of service, are enrolled as members of presbytery with voice and vote. Any ruling elder serving as a committee representative to a particular meeting of presbytery in the absence of the chair shall have the privilege of voice and vote for that particular meeting of the presbytery. Persons certified in church service who are ruling elders shall have the privilege of voice and vote at all meetings of the presbytery, during their term of service in ministry in the presbytery of Middle Tennessee. Persons certified in church service, who are members of congregations in the Presbytery of Middle Tennessee, shall have the privilege of voice at all meetings of the presbytery during their term of service in a congregation or other ministry validated by the presbytery. Should a question arise concerning the enrollment of any person, the presbytery may resolve the matter upon the recommendation of the Permanent Judicial Commission. Corresponding members were seated without objection and are listed with the roll (Attachment A).

#### **AGENDA**

The moderator stated that the agenda, including the consent agenda, had been provided in advance. The agenda including the consent agenda, was approved without objection.

#### **EXECUTIVE PRESBYTER'S REPORT**

The Rev. Ray Thomas, Executive Presbyter, delivered his report. He made remarks about the staff, his recently announced resignation effective June 1, 2024, and underscored the importance of the entire Presbytery cultivating the covenantal practices of love and trust as a PCUSA council.

# Debra Gentry, Downtown Presbyterian, Nashville

Rev. Thomas invited Ms. Debra Gentry, chair of the PNC at Downtown Nashville to speak; she remarked on the challenges her committee faced as it searched for an installed pastor and the positive experience her committee had with its COM liaison, Debra Van Derveer, and with COM Chair Erin Howton Angel.

#### Frank Dimmock

Rev. Thomas then invited Frank Dimmock of The Outreach Foundation to speak on the vibrant work across the continent of Africa with congregations as well as the needs. Mr. Dimmock alerted the presbyters to these needs and possible ways to address them.

#### Ryan and Sam Moore

Rev. Thomas invited the Rev. Sally Hughes to recognize Ryan and Sam Moore, who have resigned their posts as directors of NaCoMe. Ryan Moore spoke of their work and thanked the presbytery for its support.

Rev. Thomas concluded his report.

Moderator Yates adjourned the meeting for lunch and reminded everyone to reconvene following.

Following lunch, Moderator Yates reconvened the meeting.

#### **ADMINISTRATIVE COMMITTEE**

The Rev. Mark Bryan, made the report of the Administrative Committee in the absence of Chair Elinor Foster.

November 9, 2023 Stated Meeting

The Administrative Committee approved plans for the November 9 presbytery meeting to be held at First, Clarksville; David Paduil, who will be commissioned as a ruling elder, will preach. The offering will go to the Sudanese American Nuer Church. Frank Dimmock will bring greetings from the Outreach Foundation and Be Smart for Kids will have a table in the foyer. The Committee declined to allow the Texas Presbyterian Foundation to be present with a table display.

# Approval of Agenda

The Administrative Committee approved the Agenda including the Consent Agenda for the November 9, 2023 Stated Meeting .

# Review of August 9, 2023 Stated Meeting

The Administrative Committee reviewed the August 9 stated meeting and directed that future Zoom meetings would include longer times for voting to take place.

# **Deferred Discussion**

The Administrative Committee deferred discussion on the language describing the Legal Taskforce and a policy concerning third party grant participation requests.

# Realtor engagement

The Administrative Committee concurred with the Finance Committee's decision to engage Chris Adams as realtor to assist with the sale of the New Hope Church Property.

# Bequest of Lisa Houx

The Administrative Committee concurred with the Finance Committee's decision to place a bequest from Lisa Houx to the general presbytery fund.

#### Trinity Presbyterian Church

The Administrative Committee concurred with the Finance Committee's decision to ask the attorneys working on an agreement involving Trinity for a Memorandum of Understanding to include Steve Douse in further meetings regarding the agreement.

Attendees at Mid Council Financial Conference and the Moderators Conference

The Administrative Committee endorsed the attendance of two representatives to the Mid-Council Finance Conference on November 15-17. Evelyn Graham and Mary Catherine Sevier will attend and the committee encouraged the use of the resources from the Presbyterian Foundation, particularly Sandra Moon, who is assigned to work with PMT. The Administrative Committee also approved the attendance of the Rev. Jane Herring, Moderator-in-Nomination and Ruling Elder Elinor Foster, Vice Moderator at the Moderators Conference November 9-11.

# Parity Schedule for 2024

The Administrative Committee approved the parity schedule for 2024 which will be distributed to clerks of session and pastors.

# Proposed Slate of Officers and Committee Members

The Administrative approved the proposed slate to be presented to the Presbytery by the Nominating Task Force for approval.

# 2024 Proposed Budget

The Administrative Committee received a report from the Personnel Task Force and the Finance Committee. The Committee endorsed the proposed 2024 budget.

# Policy Compliance Task Force

The Administrative Committee approved the creation of a Policy Compliance Task Force, which will be tasked with reviewing current policies and proposing new policies as needed for compliance with the Book of Order and Mission and Operation. The Task Force will consist of at least three persons and be chaired by a member of the Administrative Committee.

# **Boundary Training**

Rev. Bryan noted that the Presbytery is not in compliance with the requirement of boundary training every 36 months as required by the Book of Order. He called upon the Rev. Erin Howton Angel who presented a short summary of the proposed training to be approved. The training will be provided by Praesidium and will be in an on demand format. A schedule and instructions will be provided. Rev. Bryan brought the recommendation from the Administrative Committee to approve this training. The Moderator called for discussion and vote, and the motion was approved.

# Exhortation from Committee on Church Transformation

At the conclusion of the Administrative Committee Report, the Rev. John Hilley asked to address the Committee. He asked of the Administration Committee if a process has been identified around the search process and particularly concerning priorities guiding the search process. Towards that end, he, in his capacity as chair of church transformation, urged the committee to elevate to an important concern the matter of church transformation work (e.g. church revitalization, new worshipping communities, new church development).

# FINANCE COMMITTEE

The Rev. Evelyn Graham, chair of the Finance Committee, presented the following information and discussed the financial statements for the past quarter. (Attachment B).

# Committee Membership

The Finance Committee welcomed Rev. Jim Moran to the committee to replace Rev. Steve Thomas. Rev. Toby Mueller has resigned from the committee.

# Stewardship Workshop

The Finance Committee and the Presbyterian Foundation sponsored a stewardship training for churches on August 19 at First Presbyterian, Nashville. All churches in the presbytery were invited to attend through the presbytery's e-newsletter. The training was well received with approximately 20 people attending from 12 churches.

#### Charitable Bequest

A charitable bequest was made to the Presbytery of Middle Tennessee from the estate of Lisa D. Houx for \$54,418.81. This money will be used in the presbytery's general account with no restrictions as to its use.

# **Engagement of Realty Services**

The Finance Committee approved Rev. Chris Adams to represent the presbytery in selling the following church properties: New Hope Presbyterian, Franklin, Central Presbyterian, Culleoka, and Brick Church, Cornersville. All three churches are currently closed.

# Trinity Presbyterian Church

The Finance Committee received a letter of intent from Rev. Sally Hughes regarding a potential long-term lease between Trinity Presbyterian and the Linden Waldorf School.

#### Statements and Accounts

Rev. Graham noted that the Vanguard account is performing better than earlier in the year, and make remarks regarding the budget tracking.

# Proposed Budget 2024

Rev. Graham admitted the following observations to record regarding the budget and the budget working group, which was composed of ruling and teaching elders including the Executive Presbyter. The group projected operating income for the coming year and consulted with Presbytery's committees and staff to determine how that money can best be used to support our mission.

- The estimate for pledged giving was increased for 2024 from the 2023 budget by approximately \$16,000 based on higher amounts received from churches for 2023 year to date.
- Our investments at Vanguard, overseen by Anders Hall, are held in 60% stock and 40% bonds. These investments have increased in value by approximately 5% during 2023, giving us increased investment income over previous years. We increased the investment income budget line item based on an average calculation as laid out in our Financial Policies and Procedures.
- As in previous years, payments made to the General Assembly (GA) and Synod are the presbytery's largest expenses and pay for the missional and operational expenses of the denomination. The rates are based on denominationally set per capita amounts times the active members in our presbytery. For this budget the Synod per capita rate of \$3.98 and the GA per capita rate of \$9.80 is multiplied by a membership of 14,987 members.
- Most increases requested by our mission partners were able to be met. Each presbytery committee has
  been given budgeted funds or has funds in designated accounts to meet their missional needs. Unlike
  budgeted amounts, designated funds carry over from year to year and are available until the fund is
  depleted.
- An external audit of the presbytery's finances is required by our Financial Policies and Procedures Manual every 5 years. This external audit is due for 2023 with expenses to occur in 2024. An audit is much more extensive and expensive than an external auditor review conducted in other years. The 2024 budget reflects this increase in expense for such an external audit.

Rev. Graham then recognized Ruling Elder Hal Sauer, a member of the budget working group, who presented the budget, noting that the Finance Committee is tasked with recommending a balanced budget and that this budget reflects the additional line items of potential legal fees as well as monies for an Executive Presbyter Search and an external audit as required. Because of the sensitive nature of some of the discussion regarding personnel, Executive Presbyter Ray Thomas, Stated Clerk Mary Catherine Sevier, and Operations Coordinator Gregory Taylor were temporarily dismissed from the meeting. Ruling Elder Betsy Bond, member of the Administrative Committee, took the minutes in Mrs. Sevier's absence. Mr. Sauer presented the budget and the Rev. Graham presented the motion out of the Finance Committee and endorsed by the Administrative Committee that it be approved. Moderator Yates asked for discussion, and the Rev. Sally Hughes presented an amendment in writing that the 2024 budget be amended to include a 4% raise for our Executive Presbyter, Ray Thomas. The motion was seconded, and the Rev. Hughes was recognized to speak to the amendment. The Rev. Heidi Hudnut-Beumler also spoke in favor of the amendment and noted that the Personnel Task Force recommended raises for all staff employees based on the annual review process to the budget working group. Rev. Hudnut-Beumler further elaborated on that process. The 4% annual raise, which totaled salary, housing, FICA, and 403b was projected to increase the budget by approximately \$2400 prorated to reflect the impending retirement of the Executive Presbyter effective June 1, 2024.

The vote was taken by paper ballot. While the amendment was approved, the total number of votes was 66, which is under the required quorum. Following discussion with the designated parliamentarian and assistant parliamentarian, the Moderator determined that all items admitted to record and actions taken following the reconvening after lunch must be ratified at either a called meeting or the next stated meeting of the Presbytery. The amended motion to approve the budget was approved by voice vote.

The Executive Presbyter, the Stated Clerk, and the Operations Coordinator were invited to return to the meeting, and the Moderator reiterated that reports were to be continued to be heard and votes were to be taken with the proviso that same must be ratified by a duly constituted quorum of the Presbytery.

#### NOMINATING TASK FORCE

Leonard Jordan, CRE and chair of the Nominating Task Force, presented the slate of committee members, officers, commissioners, ordination exam readers, and UKirk Nashville board members. He first asked for a motion to suspend the standing rules to allow two members of the same congregation, Anders Hall and the Rev. Donovan Drake of Westminster, Nashville, to serve on the Finance Committee. The motion was made and seconded. The Moderator asked if there were any discussion. There was none, and the motion was approved by voice vote and the required 3/4 majority. The motion from the task force and endorsed by the Administrative Committee to approve the slate was approved. 1

#### PERSONNEL TASK FORCE

Personnel Task Force Chair Rev. Heidi Hudnut-Beumler declined to make an oral report, but the following items were admitted to record by the Moderator.

#### Annual Staff Review Process

The Personnel Task Force has developed an annual review process for Presbytery staff, which included the input of the Administrative Committee. A new self-appraisal form has been developed, review input has been sought from people the staff member has worked with closely, and an in-depth process (including mutual goal-setting) that includes the supervisor and Personnel Task Force liaison in conversation with the staff member has resulted. Annual reviews were conducted in July and August and all had positive, affirming outcomes. We are hoping the task force's work done this year and the good results of the process lead to a regularizing of annual reviews of our staff in the Presbytery of Middle Tennessee.

#### Retirement of Executive Presbyter

The Personnel Task Force and the Administrative Committee have received the resignation and retirement of Executive Presbyter Ray Thomas effective June 1, 2024. Plans are unfolding for a celebration at the May meeting of Presbytery of Ray's dedicated leadership among us and his decades of faithful ministry in the PC(USA). The Administrative Committee will be addressing the steps into transition and will keep the Presbytery apprised. The Personnel Task Force will seek to be a helpful resource in this transition process and will remain focused on supporting our Presbytery staff.

They include: Salary, \$40,000; Housing \$30,000; Professional Expenses, \$4,000; Social Security, \$5355; BOP (2023) \$39,948; Relocation expenses, \$10,000; Signing Bonus, \$10,000; 4 weeks vacation leave and 2 week of continuing education leave.

#### The Rev. Toby Mueller

The COM dissolved the relationship between the Rev. Toby Mueller and Historic Franklin Presbyterian Church effective September 30, 2023. The Rev. John Smith was appointed as moderator of the session.

# The Rev. Jeannie Hunter

The Rev. Jeannie Hunter concluded her ministry at Bethbeiri Presbyterian Church effective October 31, 2023. The Rev. Robert Montgomery was appointed as moderator of the session.

#### The Rev. Mike MaGee

The Rev. Mike Magee concluded his interim ministry at First Presbyterian in Gallatin effective October 31, 2023. The Rev. Mark Mueller was appointed as moderator of the session. Rev. Mueller will be working with Gallatin First as a part time bridge pastor during their transition.

# Minimum Effective Salary, 2024

Minimum effective salary for installed pastors was set at \$53,680.

# Commissioning of Ruling Elders David Paduil and Rick Robinson

Rev. Angel presented the faith statements and spiritual autobiographies of Ruling Elders David Paduil and Rick Robinson discussed their examinations and recommendations for commissioning to service at the American Sudanese Church of Gallatin and Milldale, respectively. REs Paduil and Robinson were introduced and the Moderator asked for any questions from the Presbytery. There were none, and Rev. Angel escorted them out of the sanctuary for the vote. Moderator Yates asked for discussion; after some brief questions of the examinations team, the motions to commission them were voted on and approved. They were welcomed back to the sanctuary and the Moderator asked them the constitutional questions, which were answered in the affirmative.

# Dissolution of Administrative Commission of Mattie Smith Memorial

Rev. Angel announced that the Administrative Commission for Mattie Smith Memorial Church had completed its work and that the final action of disposing of the real property was to be completed by the Trustees. The motion out of the COM to dissolve the commission with thanks was approved.

# FINAL REPORT ADMINISTRATIVE COMMISSION MATTIE SMITH MEMORIAL PRESBYTERIAN CHURCH SILVER POINT, TENNESSEE

October 16, 2023

The Administrative Commission for the Mattie Smith Memorial Presbyterian Church at Silver Point, Tennessee, was appointed on July 17, 2021. It consisted of:

RE Linda Burgess (Mattie Smith Memorial, Silver Point) RE Jim Petersen (First Franklin) TE David Eisenmenger (Honorably retired) TE Evelyn Graham (Memberat-Large)

There were only two remaining members of the church. Linda Burgess and Ms. Peggy Fisher. Ms. Fisher passed away during the pendency of the commission's work. Linda Burgess was the clerk of session and had the checking and savings accounts. Those were turned over to the Trustees.

There were no minutes of Deacons. There were no remaining members who needed to be contacted. The few remaining persons of interest were members of Linda Burgess and Peggy Fisher families.

David Eisenmenger withdrew from the Commission due to ill health issues. Linda Burgess determined that she had a conflict and withdrew. Her son-in-law owns the property where the septic tank is located.

A closing worship service was conducted on December 12, 2021. Ray Thomas preached the closing service.

The church building is located on a very small triangle at the intersection of the Center Hill Dam Rd. and the Dr. Smith Rd. in Silver Point, Tennessee. It contains 0.415 of an acre, more or less. When Presbytery chooses to dispose of the property, the commission had the property surveyed, and also gathered copies of all deeds of the church property from the time it was constructed in 1944 to the present day. Those documents will be available if needed.

The Commission had the property appraised and it appraised at \$3 5,000.00. It is in very poor repair. The property was appraised by David M. Mainord, MAI, AI-GRS Mainord & Associates 167 West Main Street Cookeville, TN 38506-5336. A copy of the appraisal is available if needed by the trustees.

The Commission engaged a real estate agent, Gina Key, in Cookeville to try to find a buyer. The property is in very bad repair and the septic tank for the property is on an adjoining tract. No prospective buyer has agreed to close on the property. The Commission determined that there was no personal property on the site that would make it worth holding any kind of auction or sale. There are the pews, some tables, some china, and some flatware. The Commission decided to give the piano to the Buffalo Valley Presbyterian Church. The grandson of Mattie Smith requested that he be allowed to remove one small pew as a memorial to his grandmother. That has been placed in a nearby Baptist Church which he attends with a plaque on it commemorating Mattie Smith.

#### Evelyn Graham James Petersen

At the conclusion of Rev. Angel's report, one presbyter asked a question regarding new minister members and opportunities to meet them. The COM is considering ways to accommodate more fellowship amongst members.

# **COMMITTEE ON SOCIAL JUSTICE**

The Moderator recognized the Rev. Claire Berry of the Committee on Social Justice. Rev. Berry shared the results of the recent survey of churches regarding their work in the area of social justice. Seventeen churches participated; the top areas of social justice work were poverty, housing, and children and youth. Among other salient points, she noted that the needs identified were (1) educational materials (2) networking assistance (3)connecting to funds and (4) help with church communications. The report will be attached to the minutes.

The Task Force will maintain an Employee Manual and Job Descriptions and all records necessary for payroll. The Task Force will be comprised of at least three individuals who are elders (both Teaching and Ruling) in the Presbytery's churches. The chair of the Task Force shall be a member of the Committee on Mutual Support.

## PRESBYTERY OF MIDDLE TENNESSEE MINUTES OF CALLED MEETING NOVEMBER 30, 2023

The Called Meeting of the Presbytery of Middle Tennessee met via Zoom on Thursday, November 30, 2023. Stated Clerk Mary Catherine Sevier provided Zoom tips and verified the required quorum. Moderator Stephen Yates called the meeting to order at 11:00 am and opened with prayer.

# ADOPTION OF AGENDA/DECLARATION OF QUORUM / STATEMENT OF PROCEDURES / FIRST TIME COMMISSIONERS / CORRESPONDING MEMBERS

Moderator Yates declared a quorum was present. The Presbytery's Mission and Operations Manual provides that a called meeting may be held providing the Administrative Committee has called it by submitting the call in writing to the Stated Clerk and the call has gone out 7 days before the meeting. The quorum for called meetings is 12 Teaching Elders and 12 Ruling Elders from different churches. Should a question arise concerning the enrollment of any person, the presbytery may resolve the matter upon the recommendation of the Permanent Judicial Commission. Corresponding members were seated without objection and are listed with the roll (Attachment A). The Rev. Dr. John A. Hinkle, jr. was designated as parliamentarian.

#### **AGENDA**

The Moderator stated that the only two items of business which could be property considered were the approval of the consent agenda which listed all items of record and actions taken without a quorum at the stated meeting of November 9, and the nomination of a YAAD to the 226<sup>th</sup> General Assembly. These items of business were stated in the call.

### APPROVAL OF CONSENT AGENDA

The Moderator explained that the consent agenda listed all items admitted to record and actions taken by the body at the stated meeting, although no quorum was detected. Those items and actions must be ratified by the Presbytery at a meeting with a duly constituted quorum. He reminded presbyters that any voting commissioner or member could ask that any item be removed and considered separately. He then asked if anyone wished to remove an item from the consent agenda. There were no items removed. The Moderator asked for a motion to approve the consent agenda. The motion was seconded. There was no discussion. The motion passed.

The Moderator then recognized Commissioned Ruling Elder Leonard Jordan, chair of the Nominating Task Force. Mr. Jordan presented the name of Anne Catherine ("AC") Oeser as a nominee for the PMT Young Adult Advocate Delegate to the 226<sup>th</sup> General Assembly. The Moderator asked for nominations from the floor; there were none. The Moderator asked for discussion, and seeing none, called for the vote. The motion was approved.

A motion was made to adjourn. The Moderator called for a second; there was no discussion, and the motion was approved. The Moderator offered closing prayer and adjourned the meeting at 12:15 pm.

## PRESBYTERY OF MIDDLE TENNESSEE MINUTES OF CALLED MEETING JANUARY 11, 2024

The Called Meeting of the Presbytery of Middle Tennessee met via Zoom on Thursday, January 11, 2024. Stated Clerk Mary Catherine Sevier provided Zoom tips. Moderator Elinor Foster called the meeting to order at 9:02 am and opened with prayer.

# ADOPTION OF AGENDA/DECLARATION OF QUORUM / STATEMENT OF PROCEDURES / FIRST TIME COMMISSIONERS / CORRESPONDING MEMBERS

Moderator Foster declared a quorum was present. The Presbytery's Mission and Operations Manual provides that a called meeting may be held providing the Administrative Committee has called it by submitting the call in writing to the Stated Clerk and the call has gone out 7 days before the meeting. The quorum for called meetings is 12 Teaching Elders and 12 Ruling Elders from different churches. Should a question arise concerning the enrollment of any person, the presbytery may resolve the matter upon the recommendation of the Permanent Judicial Commission. Corresponding members were seated without objection and are listed with the roll (Attachment A).

#### **AGENDA**

The Moderator stated that the only item of business which can be properly considered today is the offer to buy land which formerly held the New Hope Presbyterian Church in Franklin, TN. This item of business was stated in the call.

#### OFFER TO PURCHASE PROPERTY

The Moderator recognized Evelyn Graham, Chair of Finance to provide history and context to the property and the offer in question. The Rev. Graham did so, and recognized the Rev. Chris Adams to bring the specifics of the offer to the commissioners. The Rev. Adams did so.

The Rev. Graham stated the following motion:

A motion is brought from the Finance Committee and endorsed by the Administrative Committee to accept the offer of Lifestream Church to purchase the property of the former New Hope Presbyterian Church for \$405,000. This sale will close on January 24, 2024, or such reasonable time as both parties agree should unforeseen events cause the closing to be delayed.

There was no discussion, and the motion was unanimously approved. The Rev. John Hilley asked for clarification as to how the funds would be distributed. The Rev. Graham noted that because of the uncertainty of costs related to the transition process of calling a new Executive Presbyter, the Finance Committee with the concurrence of the Administrative Committee will put the funds temporarily in the general operating fund.

A motion was made to adjourn. The Moderator called for a second; there was no discussion, and the motion was approved. The Moderator adjourned the meeting at 9:20 am.
