The 156th Stated Meeting of the Presbytery of Middle Tennessee met in person at First Presbyterian Church, Murfreesboro, on Saturday, May 11, 2024. Stated Clerk Mary Catherine Sevier provided an orientation for first time commissioners. Moderator Elinor Foster called the meeting to order at 10:07 am.

ADOPTION OF AGENDA/DECLARATION OF QUORUM / STATEMENT OF PROCEDURES / FIRST TIME COMMISSIONERS / CORRESPONDING MEMBERS

Moderator Foster declared a quorum was present. The Presbytery's Mission and Operations Manual and the Book of Order provide for the seating of corresponding members and teaching and ruling elders with voice and those with voice and vote. Any ruling elder serving as presbytery's Moderator, Vice-Moderator, Moderator-in-Nomination, chairs of committees, members of the Administrative Committee, members of the Finance Committee, and the Moderator of Presbyterian Women, are enrolled as members of presbytery and shall have voice and vote. Ruling elders commissioned to particular pastoral service and ruling elders who have previously served as presbytery moderator, within five years of completion of his/her term of service, are enrolled as members of presbytery with voice and vote. Any ruling elder serving as a committee representative to a particular meeting of presbytery in the absence of the chair shall have the privilege of voice and vote for that particular meeting of the presbytery. Persons certified in church service who are ruling elders shall have the privilege of voice and vote at all meetings of the presbytery, during their term of service in ministry in the presbytery of Middle Tennessee. Persons certified in church service, who are members of congregations in the Presbytery of Middle Tennessee, shall have the privilege of voice at all meetings of the presbytery during their term of service in a congregation or other ministry validated by the presbytery. Should a question arise concerning the enrollment of any person, the presbytery may resolve the matter upon the recommendation of the Permanent Judicial Commission. Corresponding members were seated without objection and are listed with the roll (Attachment A). The Moderator also announced that the Stated Clerk had requested that RE Phil Kemmerly of FPC Clarksville serve as assistant parliamentarian and CRE Leonard Jordan of St. Andrew serve as assistant stated clerk. These were both made without objection.

WELCOME

The Rev. Dr. John A. Hinkle, jr, Senior Pastor at FPC Murfreesboro, offered words of welcome. Moderator Foster then announced that worship would commence.

WORSHIP

Dr. Hinkle and the Rev. Terry Newland led worship with Rev. Newland delivering the sermon on receiving and extending grace within and without the presbytery and our local congregations. The offering was provided for Nourish Food Bank, Valerie Rains, Jocelyn Fisher, and the FPC Murfreesboro along with RE Joanna Riggs on flute and Greg Lawson on clarinet provided inspiring music including "Festival Piece on Nicea", "Hymn of Mercy", and "The Rejoicing" from Suite in G by Charles Callahan. The Lord's Supper was administered with the assistance of REs Katie Peachy and Mary Catherine Sevier.

Following worship, there was a short break, and the Moderator reconvened the meeting at 11:25 am.

REMARKS FROM THE SYNOD OF LIVING WATERS EP AND ACTING STATED CLERK

Moderator Foster recognized the Rev. Greg Goodwiller, Executive Presbyter and Acting Stated Clerk of the Synod of the Living Waters. He brought greetings to the body and noted that the church is at its connectional best during times of transition. He assured the body of the synod's prayers and other support during its process of calling an installed executive presbyter.

ADMINISTRATIVE COMMITTEE

RE Chris Williams, vice-chair of the Administrative Committee, presented the following report.

Bridge Executive Presbyter

The "Bridge EP search team" has been dissolved and we welcomed our new Bridge EP on March 18, 2024, the Rev. Terry Newland.

Return to In-person Stated Meetings and Location of August Stated Meeting

The Administrative Committee voted to return to in-person stated presbytery meetings; called meetings may be by Zoom format as determined on a case-by-case basis. The August 2024 stated meeting will be held in person at Second Presbyterian Church rather than by Zoom. A hybrid format is not being considered right now.

Clarification on Trinity Task Force

The Trinity Task Force is a temporary task force of the Finance Committee, not a joint task force of Admin and Finance.

Gracious Separation Isaiah 1:18 team

St. John Presbyterian Church of Fayetteville has filed for gracious separation. An Isaiah 1:18 team is being appointed and will be working with the congregation through the Isaiah 1:18 Gracious Separation Process.

Committee Resignations

The Administrative Committee was informed of the following resignations and subsequently informed the Nominating Task Force: Committee on Leadership Excellence: Aaron Stauffer, TE, Class of 2024 and Commission on Ministry, Ora Bransford Lux, RE, Class of 2026, Mark Mueller, TE, Class of 2025.

156th Stated Meeting

The offering for the 156th Stated Presbytery Meeting May will go to the Nourish Food Bank.

Nueva Vida Food Bank Task Force

The Administrative Committee recommended and brought a motion that the Nueva Vida Task Force which reports to the Committee on Mutual Support be made a standing task force. The motion passed.

Amendments of Manual of Missions and Operation

The Administrative Committee recommended and brought a motion that the Manual of Missions and Operation be amended on page 17 to include the word "Standing" in the description of the Nueva Vida Task Force. The Administrative Committee further recommended and brought a motion that the Manual of Missions and Operation be amended on pages 6 and 16 to delete reference to the Pastors-to-Pastors program. This recommendation came at the request of the Commission on Ministry because said program no longer exists. These recommendations required a 2/3 vote and both passed.

FINANCE COMMITTEE

The Rev. Evelyn Graham, chair of the Finance Committee, presented the following information and discussed the financial statements for the past quarter (Attachment B). She noted that while pledged giving is over budget for March 2024, the presbytery is running currently with a deficit. The Finance Committee is not alarmed, and believes that pledged giving will continue and will increase as the year progresses.

Central Presbyterian, Culleoka

An invoice of \$20,000 was received for the demolition of Central Presbyterian Church in Culleoka, TN. Included in this bill is a fine of over \$8,000 for the failure to demolish the building in a timely manner. The payment of this invoice is the result of the change in designated account 3001-43.

Food Bank Grant

The Matthew 25 Food Project, Acct 3002-33, received a \$40,000 grant from the Kharis Foundation.

Trinity Task Force Additional Appointment

An additional member was added to the task force assigned to work with Trinity. This addition was in response to the presbytery's desire to diversify the task force. John Hinkle (TE, Murfreesboro, First) was added to the three original members of Steve Douse (RE Nashville, First), Allen Kennedy (RE Nashville, First), and Jane Herring (TE Chair of Admin).

COMMISSION ON MINISTRY

The Rev. John Smith, co-chair of the Commission on Ministry, presented the following report

Pulpit Supply List

The Rev. Stephanie Boaz and Kimberly Coward were added to the pulpit supply list after a sustained exam.

Glencliff Supply

The Rev. Jason Loscuito, a minister of another denomination, was approved to serve at Glencliff as Supply through July 7, 2024.

Moderator of Woodland PC

The Rev. Evelyn Graham was appointed moderator for the Woodland Church.

Exit Interview

An exit interview was conducted with The Rev. Adrian White.

Former Pastor Policy

Editorial changes were approved to the Former Pastor Policy to ensure gender inclusive language.

Ministerial Compensation Policy

In accordance with the Book of Order, Terms of Dissolution were attached to the Ministerial Compensation Policy.

Dissolution of Pastoral Relationship

The call between The Rev. Chris Joiner and First, Franklin was dissolved with an effective date of May 31, 2024 and upon this date he is being released to The Presbyterian Church of Canada.

Reception of Eun Joo Kim

The Rev. Dr. Eun Joo Kim was examined and received into the presbytery as a validated minister serving as a preaching professor at Vanderbilt Divinity School.

Pulpit Supply Policy

A Pulpit Supply policy was adopted as amended for the presbytery.

Background Checks

Background checks were ordered for all individuals on the pulpit supply list.

Congratulations to Amy Stoker

The newly Rev. Dr. Amy Stoker was celebrated for her accomplishments in earning her Doctor of Ministry.

Board of Pensions Benefits Plan and Dues Structure

The COM heard a presentation from Keenan Rodgers concerning the new Board of Pensions Benefits Plan and Dues Structure.

THRIVE Seminar

The Pastoral Care Team is working with the Board of Pensions to host a THRIVE conference in Nashville at Westminster Church on September 26-27, 2024.

Katie Ory, Temporary Member

The Rev. Katie Ory was received as a temporary member of the presbytery in accordance with G-2.0506.

Renouncement of Jurisdiction

The Rev. Kaye Pickens Nickell was removed from the roll at her renouncing of her jurisdiction.

Dissolution of Central Presbyterian, Culleoka Administrative Commission

The Rev. Smith brought a motion from the Commission that the Culleoka Administrative Commission be dissolved with thanks and that the final report be included in the permanent record. The motion passed.

Final Report of the Administrative Commission For Central Presbyterian Church, Culleoka, TN

On October 21, 2021, during the one hundred forty-sixth stated meeting of the Presbytery of Middle Tennessee, the Committee on Ministry, at the request of the Central Presbyterian Church, Culleoka, TN, recommended that the Presbytery of Middle Tennessee create an Administrative Commission for the dissolution of its congregation.

The COM recommendation was passed with the following members elected to serve on the Administrative Commission (AC): David Sawyer, HR; Pat Bridges, RE, First Columbia; C.S. (Steve) Thomas, HR; and William Russell, RE, First Springhill. Rev. Thomas was elected moderator at the organizational meeting of the AC.

Actions of the Administrative Commission

In keeping with the charge and instructions provided, the Administrative Commission has assisted the session and members of Central PC in winding up the affairs of the church, planning and holding a closing worship service, receiving the records of the church to be appropriately archived, and begun the disposal of the building and contents of the church so that the property could be ready to be sold.

The salvage rights to the building were sold to Southern Architectural Company of Cullman, AL. Following that company's work, the building was demolished by the Maury County Building and Zoning Department. A survey was ordered and is complete. The AC has asked the Trustees to continue the process of selling the property.

Central Presbyterian Church was built in 1911 in a Gothic revival style. It featured beautiful stained glass including rose windows, large open ceilings, and lovely woodwork throughout the sanctuary. Among its first and most active members were the Park family, of the Park cantaloupe fame. This family and product was responsible for much of the affluence Culleoka enjoyed especially during that time. Unfortunately the congregation began to dwindle and the building fell into grave disrepair. The congregation moved its worship services to a neighboring church and a few years later requested the assistance of the AC.

In February of 2024, the Administrative Commission moderator told Executive Presbyter Ray Thomas that the Commission had completed its charge and requested to be dissolved at the one hundred fifty-sixth meeting of the presbytery on May 11, 2024.

We give thanks for the ministry and for the members and ministers who were part of Central Presbyterian Church.

Remarks from Keenan Rodgers, Board of Pensions

Rev. Smith recognized Keenan Rodgers of the Board of Pensions, who gave an update on the Board's work and noted that benefits are steadily increasing, including grants for a variety of situations. His remarks were a follow up to an optional workshop which he presented before the Stated Meeting began.

LUNCH

Moderator Foster announced the meeting would recess for lunch and recognized the Rev. Bobby Harding to offer the prayer of thanksgiving. Attendees adjourned to the Common Room where they enjoyed a delicious and beautiful lunch with gracious hospitality from FPC Murfreesboro volunteers.

PERSONNEL TASK FORCE

Lavona Russell presented the report of the Personnel Task Force. She noted that the hiring on March 18, 2024 of the Rev. Terry Newland as bridge Executive Presbytery is a positive force in the presbytery. The task force continues its work on the process of calling a Transitional Executive Presbyter.

COMMITTEE ON PREPARATION FOR THE MINISTRY

The Moderator recognized the Rev. Lisa Hermann, vice-chair of the Committee on Preparation for the Ministry. The Rev. Hermann made the following motions out of committee:

Receiving of Kimberly Coward, member of First, Franklin, as Inquirer

The session of First, Franklin enthusiastically supported Ms. Coward's desire to become an Inquirer. She was examined by the CPM in April, 2024. The CPM moved that she be received as Inquirer under the care of the presbytery. The motion carried.

Certifying Ashley Higgins as Ready to Receive a Call

The CPM moved the certify Ashley Higgins, a candidate under the presbytery's care and a member of First, Nashville as ready to receive a call. Ms. Higgins has completed her requirements as both Inquirer and Candidate, was examined by the presbytery and voted to become a candidate on May 6, 2023, and was examined again by the CPM in April, 2024. The motion carried.

Withdrawal of Keith Vinson and Lauren DesLauriers as Candidates

The CPM moved to withdraw Keith Vinson and Lauren DesLauriers from the care of the presbytery at their requests. The motion carried.

COMMITTEE ON MUTUAL SUPPORT

The Moderator recognized the Rev. Bobby Harding, chair of the Committee on Mutual Support, to make the report.

Hunger Grants

The Committee awarded two hunger grants: \$2500 to FPC Smyrna for a church-wide meal packaging event with the organization, Rise Against Hunger, and \$4000 for Nueva Vida Food Project, which seeks to "feed the hungry, undermine the systemic poverty and racism in our area, and to create vitality at Nueva Vida and other churches in the Presbytery that participate."

Guatemala Task Force

Rev. Harding recognized REs Lavona Russell and David Carlton to make a report from the Guatemala Task Force. Ms. Russell thanked the presbytery for its prayers, donations and work on behalf of the task force. She noted that it is governed by a covenant agreement which is renewed every three years with their partners in Guatemala. She also noted that because the Rev. Mike MaGee has moved from the area, the Task Force needs a new leader who has medical training. Dr. Carlton then brought information about the growth and success of the Basico program. This initiative has bridged the barriers that Guatemalans face in attaining education such as fees, transportation, and access. The program has grown from five students to 36.

COMMITTEE ON SOCIAL JUSTICE

The Moderator recognized Ruling Elder Henry Deaderick, chair of the Committee on Social Justice. Mr. Deaderick advised the presbytery of an opportunity to learn more about the conflict between Israel and Palestine by attending a lecture given by Michael McRay on Saturday, May 18th, at St. Andrew's PC.

REPORT OF THE BRIDGE EXECUTIVE PRESBYTER

The Moderator recognized the Rev. Terry Newland to make the report of the executive presbyter. Rev. Newland noted the good work he is seeing across the presbytery and the warm relationships between members. He expressed his optimism at the work being done.

REPORT OF THE STATED CLERK

The Moderator recognized Mary Catherine Sevier, stated clerk. Mrs. Sevier thanked the 81% of churches who submitted at least one page of the required data for the statistics report. She also encouraged the body to read the supplemental reports in the packet. Finally, she asked the body to pray for the commissioners and volunteers who are attending the 226th General Assembly from Middle Tennessee Presbytery, and she noted that in person peer review of session minutes would take place later in the year.

State of Nashville Data Workshop

The Committee on Church Transformation presented a workshop by Adam Buzard on data collected from citizens of Metro Nashville which illuminated the opportunities for our congregations to better serve u=our communities..
